



Corporate Services (Audit) Assistant/Senior Accountant Cambridge or Huntingdon

We have an opportunity within our Audit team for an Assistant or Senior Accountant to join us: the role can be based at either our Cambridge or Huntingdon office.

At **Assistant** level you may currently be part or fully AAT qualified and/or ICAEW/ACCA part-qualified, and looking to continue your professional training. Study support will be considered, and where provided you will be recruited as a 'Trainee Accountant'. You must also have a minimum of one year of recent experience of Corporate Services work within a UK practice environment to be considered. If seeking study support, you should also meet one of the following academic criteria:

- A minimum of 2 A levels at Grade C or above (including Maths) OR the equivalent standard in a business-related vocational qualification. If you do not hold a Maths A level, then we expect a minimum attainment of Grade B/Grade 6 in GCSE Maths.

OR

- A graduate with a minimum 2:1 degree.

At **Senior** level, you will already be ICAEW/ACCA qualified, or qualified by experience, with at least 3 years of recent experience in Corporate Services work within a UK practice environment.
